The remand roster duty for the month of August in the year 2020 will be prepared and published by the Ld. Chief Judicial Magistrate, North 24 Parganas, Barasat accordingly.

Accounts Department, Nezarath Department, Copying Department, Statement Section, District Record Room, Forms & Stationary Department and Filing Section of the establishment of the District Judge, North 24 Parganas as well as in the Sub-division will remain open on the above motioned dates.

The Courts will deal with only urgent matters and urgency will be decided by the concerned P.O. Only. Hearing of bail matters will be taken up physically or by Video Conferencing.

After regular Judicial work, Court staff shall devote their time in updating the backlog of orders to be written, updating diaries, Cause Lists, CIS and other related works on account of non functioning of Courts due to lockdown.

All the Ld. Judicial Officers, Ld. Lawyers, staff members, law clerks, and litigants are to abide by the WHO norms, ICMR guidelines and advisories issued by the Ministries of Health, Govt. Of West Bengal and State Govt. Time to time to combat the spread of deadly COVID-19 like use of Mask, maintaining social distancing, use of hand sanitizer/hand wash etc.

No litigant shall be allowed inside the court premises.



For cases like Mutual Divorce or for the purpose of Examination of any witness or parties to the cases, an admission slip shall be issued by Ld. Registrar to the advocate concerned.

Each person entering the court premises shall be screened with a thermal gun and those with temperature below 99°F shall only be allowed.

Since the entry to the court premises is restricted and thorough checking is required for each one entering the building thus only One Entry gate shall be operational for the aforesaid purpose.

The learned representatives of the Bar shall depute one of their representatives along with the staff member deputed by Ld. Registrar for the purpose of screening at the gate of the Court Building.


Only those members of the Advocates shall be allowed inside the court hall/room whose matter is being called for hearing. There shall not be any unnecessary gathering inside the court room/hall for any matter whatsoever.

All the working days excepting the above mentioned schedule are reserved for the purpose of sanitization of the courtrooms, chambers of the P.O, office etc. Judge in charge of the Nezarath Department and Nazir of District Judge's Court as well as other sub-divisions of this Judgeship are directed to take necessary steps for sanitization on the reserved days.

On **31st day of August, 2020** the matter will be reviewed and further order shall follow.

The presiding officers are requested to adhere the order strictly.
