**Order No. 176 -G, dated, Barasat, the 25th day of July, 2020**

In continuation to this office earlier order no. 175-G dated 18.07.2020, this is for information to all concerned that in view of the letter dated 24.07.2020 received from the Registrar General, High Court, Calcutta, due to new phase of lock down in the district of North 24-Parganas, specially in the Sub Division of Barasat, Barrackpore and Bongaon upto 31<sup>st</sup> July ,2020 and constant increase in the containment zones and rapid increase of pandemic Covid-19 patients in this district, normal functioning of the Courts work is not possible at this stage.

It is further noticed that in addition to Naib Nazir attached to the District Judges Court, North 24 Parganas, the despatch Clerk of the English Department of the undersigned has also been tested positive of COVID-19 and was admitted in Hospital for treatment. The entire staff members of the English Department, Nezarath and Accounts Department are to be sent on Home quarantine.

In this present situation all the Judicial and administrative works of this Judgeship shall remain suspended on and from from **27.07.2020 (Monday) to 31.07.2020 (Friday)** excepting the Police Remand file.

Ld. Chief Judicial Magistrate, North 24-Parganas at Barasat and Ld. Additional Chief Judicial Magistrates at Barasat, Basirhat, Barrackpore, Bongaon, Bidhannagar to attend all urgent matters both judicial and administrative works and also attend the police remand files and connected urgent matters during the above-mentioned period. No regular record shall be put up on those dates.

In compliance with the solemn order dated 08.04.2020 passed by the Hon'ble Mr. Justice Harish Tandon and Hon'ble Mr. Justice Soumen Sen of High Court at Calcutta in connection with W.P. No. 5327(W) of 2020, corresponding to the notification No. 1548-RG dated 13.05.2020 of the Hon'ble High Court at Calcutta, Child Right Courts at Barasat, Basirhat, Barrackpore, and Bongaon in this judgeship will function to attend all urgent matters, both judicial and administrative works on **28.07.2020 and 30.07.2020** only.

The Principal Magistrate, Juvenile Justice Board, Bidhannagar, North 24 -Parganas is also directed to hold the urgent matt+914471366330rs during the said period.

On **31st day of July, 2020** the matter will be reviewed and further order shall follow.
