5. It is further resolved that the copy of the resolution be sent and or circulated amongst all the Ld. Courts, Commercial Court, Executive courts, Consumer Court and other offices of this station where the involvement of the lawyers are necessary.
6. It is further resolved that a request be made to all the Ld. Judges and Magistrate to ensure that none of the clients may suffer owing to the suspension of work by the lawyers in the shape of extension of the interim order of injunction/ stay/ bail. and limitation related matters.


