## Order No. 169 -G Dated Barasat the 15th day of July, 2021

Taking into reckoning the further extension of lock down period by the State Government till 30/07/2021 and in anticipation of order of the Hon'ble High Court, in continuation of its earlier order (Communicated vide No- 2180-RG dated 16.05.2021 and No. 2176-R (JS) dated 15.05.2021) and subject to requisite change/modification pursuant to the order of the Hon'ble court, if any, the following order is issued for functioning of judiciary in this district:-

- 1. Regular and normal court proceedings are restricted and only urgent matters shall be taken up, until further order;
- 2. Officers shall attend court and take up matters according to the roster;
- 3. Staff shall attend court according to the roster;
- 4. Filing counter shall remain open on every working day from 11 am to 12 noon;
- 5. This order shall remain valid till 30/07/2021;
- 6. All the Ld. Judicial Officers are requested to explore the possibilities and work ability of hearing of cases through Video Conference platform, subject to availability of network and also requested to carry their Laptop for Video Conferencing purpose;
- 7. In case hearing of the cases are conducted not on Video Conference, there should not be present more than 6 person in court, at any given point of time, including Ld. Lawyers and excluding the staff of court;
- 8. No congregation shall be allowed within the court premises. Existing norms and protocol to combat COVID should be strictly followed;
- 9. Courts functioning shall be abandoned at the discretion of the Presiding Officer holding the Bench, if the existing norms/protocol are flouted;
- 10. Nos. (1) to (9), as above, are applicable to the courts at Barasat, Barrackpore, Basirhat, Bongaon, Bidhannagar and Commercial Court at Rajarhat.
- 11. Cases of divorce on mutual consent under any relevant statute (pertaining to the court of District Judge) shall be fixed on each day of sitting of the bench of Ld. District Judge to take maximum number of 05 (five) cases on a particular day including listed and unlisted matters;
